The permittee(s) agree to provide to the City of Vista, a Certificate of Liability insurance naming the City of Vista, as additional insured, and which includes coverage for the effective date(s) of said Seasonal Use Permit, and with a minimum limit of liability of \$1,000,000 (one million dollars).

10. This permit does not allow any exceptions to other City Codes. The use of sound amplification is not allowed.
