

ORDINANCE NO. 2016-8

AN ORDINANCE OF THE CITY COUNCIL OF THE CHARTERED CITY OF VISTA, CALIFORNIA, AMENDING VARIOUS SECTIONS OF THE VISTA MUNICIPAL CODE TO CONFORM ADDRESSES AND TERMINOLOGY TO CURRENT USAGE

The City Council of the City of Vista does ordain as follows:

1. Findings. The City Council hereby finds and declares the following:

A. Various sections of the Vista Municipal Code ("Code") continue to refer to the old address for City Hall on Eucalyptus Avenue.

B. Various sections of the Code continue to refer to the Department of Parks and Recreation and Director of Parks and Recreation instead of the name and title associated with the new name for the department, Department of Recreation & Community Services.

C. A number is missing from the sewer capacity charge table in Section 14.06.A of the Code related to temporary seating, and the Director of Community Development has requested that the omission be rectified.

D. The City Council desires to amend the Code to update these references.

2. Action.

A. Section 1.04.020 (Definitions) of Chapter 1.04 (General Provisions) of the Code is amended to add the following definition:

"City Hall" shall mean the business offices of the City of Vista located at 200 Civic Center Drive, Vista, CA 92084-6275."

B. The City Clerk is authorized and directed to modify the text of the Code as follows:

(1) Change all references in the Code to the former Eucalyptus Drive address to refer instead to "City Hall".

(2) Change all references in the Code to Department of Parks and Recreation to refer instead to "Department of Recreation & Community Services".

(3) Change all references in the Code to Director of Parks and Recreation to refer instead to "Director of Recreation & Community Services".

C. Subsubsection 4.a.2) of Subsection A (Residential Equivalent Dwelling Units Sewer Capacity) of Section 14.06 (Sewer Capacity Charge) is amended to read as follows:

"2) Temporary seating – for each individual seat using the unconcentrated capacity formula allowed under the most current edition of the California Fire Code in the sanctuary only. .01"

D. Sections 2.A and 2.C of this Ordinance shall be codified, but Section 2.B shall not be codified.


3. Effective Date. This Ordinance shall be in effect on the 31st day following the date of its adoption.
