

ORDINANCE NO. 2016-12

AN ORDINANCE OF THE CITY COUNCIL OF THE CHARTERED CITY OF VISTA, CALIFORNIA, ESTABLISHING A 25 MILE-PER-HOUR SPEED LIMIT ON S. SANTA FE AVENUE BETWEEN MAIN STREET AND GUAJOME STREET AND A 35 MILE-PER-HOUR SPEED LIMIT ON S. SANTA FE AVENUE BETWEEN GUAJOME STREET AND POSTAL WAY

The City Council of the City of Vista does ordain as follows:

1. Findings. The City Council hereby finds and declares the following:

A. Sections 22358 and 40802 of the California Vehicle Code require that speed limits on streets classified higher than a local street on the California Roadway System Maps be established on the basis of an engineering and traffic survey in order for radar enforcement to be used.

B. An Engineering and Traffic Survey was conducted on S. Santa Fe Avenue between Main Street and Guajome Street per requirements prescribed in Section 627 of the California Vehicle Code.

C. The results of the survey indicated that a 25 mile-per-hour speed limit on S. Santa Fe Avenue between Main Street and Guajome Street is appropriate.

D. An Engineering and Traffic Survey was conducted on S. Santa Fe Avenue between Guajome Street and Postal Way, per requirements prescribed in Section 627 of the California Vehicle Code.

E. The results of the survey indicate that a 35 mile-per-hour speed limit on S. Santa Fe Avenue between Guajome Street and Postal Way is appropriate.

2. Action.

A. The speed limit on S. Santa Fe Avenue between Main Street and Guajome Street is hereby determined and declared to be 25 miles per hour.

B. The speed limit on S. Santa Fe Avenue between Guajome Street and Postal Way is hereby determined and declared to be 35 miles per hour.

C. The City Traffic Engineer is directed to install signs and markings as reasonably necessary in accordance with current California traffic engineering standards.

D. All previous determinations or declarations of the City of Vista in conflict herewith are repealed and rescinded.

E. This Ordinance shall not be codified.
